Forward requests to incur an obligation or expenditure in excess of \$500,000 to me with the appropriate rationale and justification after coordination with the Under Secretary of Defense (Comptroller). Official representation funds are to be administered in accordance with Department of Defense Directive 7250.13.

I have determined that the amounts listed under the heading "Confidential Military Purposes" are necessary for such purposes. However, I direct that you exercise prudent judgment in using this authority and that you ensure that any expenditures made are only for emergency and extraordinary expenses.
